- b) If any execution or other legal process is enforced against any of the assets belonging to the Advertiser.
- c) If a bankruptcy order is made against the Advertiser or if the Advertiser makes a voluntary arrangement with its creditors, or a winding up or administration order is made or any order or resolution is passed for the Advertiser's winding up or any receiver is appointed.

Effect of termination


